Routine Business

- 1) Secretary's Report There was no April meeting. Russell made a motion to approve the draft Secretary's Report that Dave emailed to the Board. Phil second the motion and it passed unanimously.

- 1) John & Mariah Nelson customer #102 210 Oak Hollow Ct. After a discussion, Rick made a motion to forgive all but \$250 of their water bill. The motion didn't get a second and died. Phil will contact PGMS to let them know that the Nelsons should be allowed a 3-month grace period to make payment of their bill. Rick will communicate with the Nelsons.

 - a. There's a dead tree at the water plant that needs to be cut down. Rick volunteered to do it.
 - b. Binney House bought by Chris & Angela Nussel. There was a water bill dispute but the real estate agent resolved it.
 - c. BSEACD declared Stage III Drought on April 17, 2013. New rate effective after May 15th billing cycle.

- d. J&K worked on pressure regulating system at the utility and it now consistently has between 52 to 67 pounds.
